


## Burning QI Question? Ask a QI Mentor.

# **CAHs Measure Up: Finding and Using Benchmarking Data**

Benchmarks can be used to look at how your hospital fares in relation to other hospitals in your state, the nation, or other groups on various measures, and to set performance goals and targets.

#### How to find benchmarking data:

- Check your MBQIP reports for data to benchmark your CAH against other hospitals in the state and nationally. The reports contain both averages and 90th percentiles for CAHs. The average represents the "middle of the road," and the 90th percentile shows you where the best 10 percent of hospitals are performing for a given measure.
- MBQIP HCAHPS reports do not contain 90th percentiles, but they do contain averages. However, HCAHPS Online is a good source

of percentile data for HCAHPS measures – scroll to the "HCAHPS Percentiles Table" to take a look. Remember that on HCAHPS Online, benchmarks represent data for all hospitals in the state and/or nation (not just CAHs)

(not just CAHs).


 Some other good sources of benchmarking data for MBQIP measures as well as other measures include quality measure and other reports from the Flex Monitoring Team. The Agency for Healthcare Research and Quality maintains a list of useful national data sources.
 Consider also reaching out to organizations within your state for benchmarking suggestions, such as your state Flex program or hospital association.



#### How to use benchmarking data:

- Track your hospital's performance
  against benchmarks ideally, use the 90th percentile. Use that benchmark as the goal you strive to
  reach (or to stay above). Consider plotting your hospital's performance on a graph and include the most
  current benchmark to visualize your progress.
   The Internal Quality Monitoring Tool, part of the Quality Improvement Implementation Guide and Toolkit
  for Critical Access Hospitals, can help you start plotting your performance in this way.
- Benchmarks can also help you set priorities for improvement. If your hospital is already performing at or above the 90th percentile for a specific measure in both your state and the nation, for example, you should celebrate and keep up the good work but you might want to focus your improvement efforts on a measure that's performing below the state or national average. Consider using the CAH Quality Prioritization Tool, also part of the <u>Quality Improvement Implementation Guide and Toolkit for Critical Access Hospitals</u>, to help determine which measures to focus on.

In general, make sure you know which time period you're looking at regardless of the data source. Your MBQIP reports often contain more recent data than what you might find in other sources, but if you request data internal to your hospital or within your state, the data could be even more recent.

#### **Hospital Quality Reporting Site Updates**

CMS is continuing to modernize their Hospital Quality Reporting (HQR) site. We've pulled together some of the information that has been emailed out regarding changes to the site. Please realize this is subject to change as CMS hasn't completed the updates as of this issue.

The link to the QualityNet home page is now https://qualitynet.cms.gov

The process for registering a Basic User or Security Administrator in the new system is as follows:

- Log into <u>HARP Sign In</u> at <a href="https://hqr.cms.gov/hqrng/login">https://hqr.cms.gov/hqrng/login</a> with your HARP user name and password.
  (No HARP account? Create one on the <u>HCQIS Access Roles and Profile page</u> at <a href="https://harp.qualitynet.org/">https://harp.qualitynet.org/</a>.)
- Go to My Profile (Under your Username in the upper right).
   From this page, you can Request access, and View Current Access.
- 3. Select **Basic User** or **Security Administrator/Official** when prompted to select a user type.
- 4. Select your required permissions and click **submit an access** request.

You will be notified by email when your request has been approved.

#### **Submitting Population and Sampling Data**

HQR users can navigate to <a href="HARP Sign In">HARP Sign In</a> at <a href="https://hqr.cms.gov/hqrng/login">https://hqr.cms.gov/hqrng/login</a> to submit their Population and Sampling Hospital Quality Reporting data. Submit Q3 and Q4 submissions using either Simple File Submissions or Data Entry process starting on November 05, 2020. To submit via **Simple File Submissions**, take the following steps.

- Submit XML files by navigating to File Upload.
- Click Population and Sampling or use step 3 below.
- From the new navigation, click Data Submissions and then Population and Sampling.

To Submit via **Data Entry** (new), take the following steps:

- 1. Go to the Dashboard.
- 2. Click Data Entry.
- 3. Click the **Select Population & Sampling** tab.
- 4. Click Data Form.
- Click IQR or OQR.

Additionally, from the new navigation, on the left-hand side of the screens, click Data Submissions > select Population & Sampling tab > Data Form > IQR or OQR.

There was a QualityNet Notification email that went out on 11/24/20 with news on the new HQR reports tool. The process will be rolled out in two phases and the e-mail discussed Phase 1. It's a bit too involved to post here but this is regarding reports you can run allowing you to analyze for file accuracy, measure results and reporting requirements for the CMS Reporting Programs.

Make sure you sign up for the email updates on the QualityNet home page to get the latest information on the latest CMS updates to the Hospital Reporting Program. I would also advise logging in to your HARP account before you try and submit data to get yourself familiar with the site changes.
