

CDC Launches Project Firstline Healthcare Infection Control Training Collaborative

In 2020, the U.S. Centers for Disease Control and Prevention (CDC) launched **Project Firstline,** a collaborative of diverse health care and public health partners



that will provide frontline health care workers the accessible, transparent, and interactive infection control training they need to protect themselves, their patients, their coworkers, and their communities. To stop the spread of infectious disease threats including the virus that causes COVID-19—every health care worker needs a foundational knowledge of infection control and must be ready to integrate infection control practices into their workday.



In December, Project Firstline launched a video series for frontline health care workers called *Inside Infection Control*. The videos feature CDC's Dr. Abby Carlson, a physician with experience on the frontlines of COVID-19. *Inside Infection Control* videos range from 3-8 minutes and are designed to describe important infection control concepts and discuss infection control actions that are important for healthcare workers to understand and apply during the current phase of the pandemic. The full *Inside Infection Control* video series can be accessed on <u>Facebook</u>. After they air on Facebook, videos are also added to <u>YouTube</u> and the <u>Project Firstline website</u>.

Additional videos are in production and new training resources will be shared on the Project Firstline website as they become available.

There are many ways critical access hospital quality improvement managers can use the Project Firstline *Inside Infection Control* training videos and related materials to support staff including:

- Sharing links to the videos in email publications, such as newsletters

Robyn Quips - tips and frequently asked questions

Data Submission Update:

Email notification came from CMS on February 26, extending the Medicare Outpatient Quality Reporting (OQR) Program's third-quarter submission deadlines for population and sampling and patient-level chart-abstracted clinical data submissions to April 1, 2021.

Were you able to attend the Hospital Outpatient Quality Reporting team webinar on February 24, 2021? If not, you can <u>view the recorded</u> <u>presentation and slides</u>.

Here are a few of my thoughts from the presentation:

- The QualityNet home page still exists. This is where you will find your Specification Manuals, CART tools, and general CMS Quality Reporting Programs information. Your secure log-in for reporting is what was moved from this site.
- Submitting data is now done through the Hospital Quality Reporting (HQR) platform by logging in through your HARP account. Once you have logged in, you can locate the site you need to submit data (Data Submissions) and check to make sure your data was received and accepted (Data Results). Other options are Program Reporting and Administration. You can refer to the recording for functions found there.
- For Population and Sampling, when you select Not Sampled, the Sampling grid will no longer automatically be filled in for you. You need to enter numbers in both grids. If you don't sample, put the same number in the Sampling grid as you have in the Population grid. If you do sample, the total population numbers for the measure are recorded under Population, and the number you are abstracting/submitting data for gets entered in the Sampling grid. If you aren't submitting data for one of the measure sets, (such as the Stroke measure) choose N/A Submission Not Required.
- After you submit your chart abstracted data, it appears you will no longer get an email from QualityNet telling you that your files were received. Instead, a green checkmark will appear with the word "Received" under the Status column. As with the emails, I think this only means your files were received, not necessarily that QualityNet accepted your individual cases. Make sure to check this by running the Case Status Summary report. You will find how to select this report by looking for Data Results under the Dashboard and selecting Chart Abstracted. Slides 46-47 from the presentation handout show the process to run the report.
- The webinar also showed how to submit web-based measures; for the MBQIP program, that would be OP-22. That data is due by May 15, and I'll talk about this in my April column. If any questions come to mind on submitting OP-22 after watching the webinar, let me know, and I will address them next month.
- Finally, the team putting on this session was the Hospital Outpatient Quality Reporting Team. They only have outpatient role access for their HARP accounts, so your screens might look a bit different if you have more user roles, such as reporting for inpatient measures. Most importantly, it was mentioned several times during the presentation that changes are not complete yet for the HQR platform, so be on the lookout for email updates. It's a good idea to log in every month and check out the screens to see if there have been any changes.
